
Medical and Dental Forms

Sick Child Policy

Reasons for sending a child home.

- Fever
- Runny nose accompanied with other symptom that is not already documented.
- Rash
- Vomiting/Diarrhea
- Lice
- Headache
- Visibly uncomfortable which does not allow children to actively participate in learning.

Documentation and Policies

- If your child was sent home from school due to illness or suspected illness, they must stay home for at 24 hours.
- If your child has a rash that lasts more than 24 hours, they will need a doctors note.
- If your child had lice, they will need a doctors note to return to school.
- If your child misses 3 or more days of school due to illness, they must return to school with a doctor's note.
- The school will not accept sleeping children, or children medicated with a fever reducing medicine under any circumstances.







Mandated Reporters for NYC

- All staff within this building are mandated reporters, and must report any signs of child abuse or neglect.







Effective Communication

- It is very important to keep open lines of communication between you and the school.

Drills- General Response Protocols

- General Response Protocols are a set of instructions that the school follows in the event of an emergency.
 - All emergency situations are handled in conjunction with first responders and 911 is always called.
 - The type of incident will determine the procedure we will follow.
 - Please be aware that in no way is fear instilled in the children during drills or training. The staff is educated on how to guide the children without causing any distress.

Lockdowns

- **Soft Lockdown: No Danger Within the School**

Soft lockdowns are put into place when the situation is outside of the school in the surrounding area. This requires the school to go into an internal lockdown and no one enters or leaves the building. Designated staff will meet and discuss next steps with the local police station.

- **Hard Lockdown: Imminent Danger**

Hard lockdowns are dangerous situations that occur within the school which include an unauthorized person within the building, or a dangerous situation that may cause harm to one or more persons within in the building. No one is allowed to move within the building. Everyone must remain in their locked designated areas until police arrive and declare a safe building.

- **Evacuations (Including Fire Drills)**

Evacuation situations such as a fire. Children and staff leave the building and await further instruction. Fire drills are done every month, in any weather.





- **Shelter In (Hold)**

Children and staff are instructed to stay inside, in a safe place until instructions of “all clear” are given. All classroom and office activities continue.





Procedures

- You will receive a letter prior to when lockdown drills begin in the school.
 - In any actual lockdown or evacuation, the entire school is made aware.
 - Children and staff are instructed to move out of sight and keep quiet.
 - Staff and teachers are trained on proper procedures, and to wait for instructions from first responders.
 - All children at all times are accounted for.
 - Families will be informed accordingly.
 - Our school follows the model put forth by the New York City Department of Education and is designed for the age group of the children within the school.
